From the Rabbi's Desk

Dear Temple House of Israel Congregants and Friends,

First, let me thank all of you who have welcomed me back and asked about my travels. I am very glad to be home. There is clearly a reason that the words travel and travail are related. I love being there, but not getting there – and the airline companies don't make it easy to think kindly of them. © The entire trip was incredibly educational and helpful. I learned so very many things, most of which will be useful in our community, as well as help me to learn and grow as a person, as a leader, as a teacher, and as a member of a Chevrah Kadisha. My sense of meaning, purpose and commitment was refreshed, and I am ready to engage in mitzvoth and community building afresh in supports of the ideals and vision that this study mission touched and helped strengthen.

From the Rabbi's Desk (con't.)

The trip was in three segments: A New York component, a Prague/Czech Republic component and an Israel component. The Israel component had both a Tsefat (Safed) and a Jerusalem focus. Each component had a different focus, a different feeling and a different set of lessons. I hope to share those lessons with congregants over the coming year.

I will offer two stories of very different things here as an example, both from the New York component. First, we had a special pre-arranged tour of the Ellis Island hospital, morque and cemetery area - not part of the usual tour. The hospital complex was simply abandoned, and only recently is in partial renovation, and in part is not thought to be repairable, so we were obliged to sign waivers, wear hardhats and stay in specific areas. Our guide was an historian who works at Ellis Island, but for the State of New Jersey (that state owns much of the Ellis Island area, only a small section is actually in New York), who did significant specialized research in advance of our trip about Jewish patients and burial of those who died on Ellis Island. In short, the hospital provided Kosher meals on request, sponsored Jewish religious services, brought in Jewish chaplains, and engaged the Jewish community to perform burial rituals for anyone identified as Jewish, and the Jewish community in New York and New Jersey was involved. We were able to see the operating theater, both the infectious disease and other wards, patient rooms and furniture, much of the structure and the grounds of the hospital. Our guide debunked a few of the myths about Ellis Island: for example, names were not changed there, that was done months before people ever boarded a ship by the steamship company employees when passage was booked; taxpayers did not pay for those at Ellis Island, that come from the steamship companies that charged a price for tickets that would defray the expenses of anyone detained at Ellis Island (or other ports) and for passage back for the 1-2% of those refused entry. What was amazing was that the Jewish community, small and poor as it may have been at times, still reached out and took care of the needs of those immigrants it never knew, at a time and in a place that was out of sight.

Second, we spent time in New York with members of the Orthodox/Haredi community. The man we met headed up the volunteer organization that sends out first responders to accidents with Jewish victims to collect all blood and body parts so that the person can be buried as fully as possible. This includes everything from searching for body parts and pieces at accident scenes, to identifying and collecting spilled blood in the area, and preparing the body ritually. These men are what we might call "Ultra-Orthodox", but hey received us with respect because we share the value of the mitzvoth of Shmirah and Taharah. The woman we met is from one Orthodox sect, but serves on the Chevrot Kadisha for multiple sects, offering her knowledge and expertise to anyone who may need it. She "doesn't work" out of the house and receives no pay, but she is involved in Taharot (ritual purifications) around the clock, any time of day or night, as many as a dozen a week, as well as serving as the coordinator for multiple Chevrot Kadisha, and her husband and children support her work with these mitzvoth. What this taught me is the Jews, no matter what their level of observance, can share and connect around the values of Mitzvot and love of Jews and Judaism. I was in awe of these people (and others) I met and proud that our community can stand with them and offer the same care and loving treatment of our members, so that we are on par with them in our values and our actions. There is so much more to say, but it is impossible to say it in the space available. Suffice it to say that I was enriched and hope to share that experience with many others.

What I want to share now is that the experience has confirmed fully the value, dignity and worth of the Jewish way in death and dying. I fully believe that every Jew should be offered the opportunity to be treated with the care, kindness respect and honor that is represented by the Chevrah Kadisha and Jewish burial customs, and that those who mourn should be supported and comforted by the Chevrah Kadisha and the Community in which they live with the sensitivity and concern that Jewish traditions offer. As well-meaning and respectful as may be those who follow other traditions, I feel that even at the best what they do lacks the dignity, simplicity, honesty and sensitivity that Jewish practices offer and represent. Jewish burial and mourning practices are significantly lower cost, green (environmentally sensitive) and dignified, support Jewish values of the worth of every human being (each of us being B'tzelem Elohim) – both body and soul, and provide honor and respect to the deceased and support and comfort to the mourners. There is deep wisdom and much experience encapsulated in the Jewish approach and I would like to see it available to and embraced by all in our community. This is a long-term goal we should work together to make a reality.

Things of note

It is already time to begin planning for the coming congregational year. A calendar planning meeting is scheduled for the last week in June, at which time we will begin to cement in the major building blocks of communal activities: holidays, celebrations, community awareness Shabbatot, Shabbat services and major activities, and then fill in with plans for Religious School, educational events and other things as they arise. If you have any suggestions or input for the calendar, please speak to me or to Rosalie between now and June 19th so it can be factored in as we make these plans.

The Torah Parashiot for the coming weeks are Be'ha'alotecha, She'lach, Korach, Chukat, Balak, and Pinchas. Rosh Chodesh Sivan was on May 19th. Rosh Codesh Tamuz wiwll be on June 17th and 18^{th.} Rosh Chodesh for Av is July 17th. We are in year 2 of the triennial cycle (the middle or second part of the cycle).

Rabbi's Message

As the current congregational year winds down and we plan for and look towards the coming year, may we all engage not only with the activities and events that go on our calendar, but with the relevant words of Torah, with the hope that those words will become holy sparks that alight and enlighten our days and nights, and that then rise up and are reunited with the divine source from which they come. May it be so.

Special Award

Rabbi Lynne Landsberg will be recognized for her years of service on behalf of people with disabilities with the inaugural Thornburgh Family Award. The award will be presented by the Interfaith Disability Advocacy Coalition, a program of the American Association of People with Disabilities (AAPD). Rabbi Landsberg will receive the award at "From Access to Inclusion", an interfaith service at First Trinity Lutheran Church, Washington DC on July 26, 2015, the 25th anniversary of the signing of the Americans with Disabilities Act (ADA), by President George H.W. Bush. "... we are thrilled to present this award to Rabbi Landsberg. Her passion and commitment to creating inclusive places of worship has ensured more people with disabilities are getting an opportunity to worship and participate in congregational activities that are welcoming and accessible. She is Senior Advisor on Disability Rights for the Religious Action Center of Reform Judaism in Washington DC, cofounder of the Jewish Disability Network, and founder and co-chair of the CCAR Committee on Disability Awareness and Inclusion. She is co-founder of Hineinu: Jewish Community for People of All Abilities, a historic and innovative collaboration of the Conservation, Orthodox, Reconstructionist and Reform Jewish Movement as well as Chabad.

The Thornburgh Family Award recognizes a religious leader who exemplifies the spirit of the ADA as demonstrated by Dick and Ginny Thornburgh's efforts to expand opportunities for people with disabilities. As U.S. Attorney General, Dick Thornburgh was tapped by then-President Bush to negotiate with Congress over legislation that became the ADA.
